REGULATIONS

ON CHANGES AND APPROXIMATES OF THE RULES ON CONDITIONS, ORGANIZATION AND METHOD OF COMPLETING TELEMEDICINE

Article 1.

In Article 5 of the Ordinance on Conditions, Organization and Mode of Performing Telemedicine (Narodne novine, No. 138/11), the words: "health workers" shall be deleted.

Article 2

In Article 8, after paragraph 6, the following paragraphs 7 and 8 are added:

»Telemedicine Centers for Telemedicine Centers can not conclude a telemedicine service contract with other telemarketing center license holders.

By way of derogation from paragraph 7 of this Article, the Minister of Health may, by way of a previously obtained positive opinion of the Institute, issue consent to the holders of approval for the operation of telemedicine centers in the basic network of telemedicine centers for the conclusion of contracts for the provision of telemedicine services with other holders of telemedicine center authorization.

Article 3

Article 10 shall be amended to read as follows:

»The Institute will propose networking for those healthcare institutions, healthcare companies and private healthcare providers that meet the requirements of Art. 27 of this Ordinance ".

Article 4

In Article 12, after paragraph 1, a new paragraph 2 is added, which reads as follows:

"Health institutions in the basic network of telemedicine centers may, with the consent of the Institute, provide equipment and information and

communication infrastructure necessary for working in the basic network of telemedicine centers."

Previous Paragraphs 2, 3 and 4 become paragraphs 3, 4 and 5.

In paragraph 4 after the word: "from paragraph 1" the following words shall be added: "and 2."

Article 5

In Article 13, after paragraph 3, paragraph 4 shall be added to read as follows:

"Telemedicine Centers in Telemedicine Centers in the Extended Network of Telemedicine Centers can conclude telemedicine service contracts and other telemarketing centers for telemedicine centers in the expanded telemedicine centers network."

Article 6

In Article 23, paragraph 2, subparagraph 2, the word "(extended)" shall be deleted.

In paragraph 2 subparagraph 8 the words: "or number of healthcare workers" shall be deleted.

Article 7

In Article 33, the word "resolution" shall be deleted.

Article 8

Article 35 is amended to read:

"When the Office finds that the conditions referred to in Article 33 of this Ordinance are met, the applicant shall be granted a permit for the operation of the telemedicine center (hereinafter referred to as "approval ") and after the applicant has been included in the Network.

Approval is granted for a period of four years.

Article 9

This Ordinance shall enter into force on the eighth day after its publication in the Official Gazette.
